## **PRESS RELEASE**

- 1. A complaint was received from ABC/Plieborlang Nongsiej (SWAT), that on 09.01.2014 @ 9.25 P.M while proceeding to his house at Umsohsun, Shillong and on reaching at Wahingdoh, Shillong near Ram Krishna L.P. school he was confronted by four boys who blocked the road and did not allow him to pass and instead assaulted him with a bottle and threatened him with dire consequences. Two of the accused persons namely Shri Jesse Obet Skhemlon of Jaiaw and Heh Kupar Nongbri of Mawprem were arrested and forwarded to Court. They have been remanded to 5(five) days police custody.
- 2. The 2 (two) persons namely (1) Shri Johny Sohkhlet, President, KSU, Lawsohtun Unit and (2)Shri Readyon Stone Nongrum @ Hep, General Secretary of KSU, Lawsohtun Unit who were arrested on 29/11/2013 for the arson case at Bishnupur, Shillong resulting in the death of Bisheshwar Das(45 years) have been booked under MPDA and are presently lodged at Williamnagar District Jail. Enough of evidence have been built up by police to prove their involvement in the case.
- 3. The Court of the Addl. Deputy Commissioner(Judicial), Shillong vide Order dated. 20.12.13 has awarded punishment of 8(eight) years rigorous imprisonment to Shri Dilip Chettri and with a fine of Rs. 1,000/- only. In default of payment of fine, the accused shall be liable for another one month imprisonment. The brief of the case is that on 27.01.2012 Shri Honroy Khongdir, Headman of Pyrnai village filed a written FIR Dtd. 27.01.2012 at Pynursla Police station to the effect that the accused person Shri Dilip Chettri on 27/01/12 at around 7.00 AM set ablaze the house of his ex wife Smti Shrak Khongtiang at Pyrnai village as a result the house was reduced to ashes and the cost of loss is approximately amounting to Rs. 2,00,000/-(Rs. Two lakhs) only. The case was investigated Sub Inspector Phrianglin Syiem 2<sup>nd</sup> O/C Pynursla Police Station.
