On 15.09.2024 @ 10.45 PM, an information was received at Jhalupara Police Out Post, Shillong from Shri Sugan Thapa R/o Jhalupara, Shillong to the effect that one male person whose photograph and description is appended below had committed suicide by hanging near Advance Diagnostic Research Centre Jhalupara, Tenzing Road, Shillong. Accordingly, inquest and other legal formalities were observed the dead body was shifted to Civil Hospital, Shillong and after PM Examination the dead body has been kept at Civil Hospital Morgue Room, Shillong, for identification and claim. This refers to Lumdiengiri PS UD Case No.
